

## "Headache Bar" Saved Little Gap Bridge from Damage

On March 25<sup>th</sup> an oversized Penske truck struck the overhead barrier near the entrance to Little Gap Bridge (PA-13-02) in Carbon County. The driver left the scene in the truck. There is an 8'-6" clearance sign on the barrier. The actual clearance for the bridge at the portal is 10'-6". The barriers were put in place in 2015 at a cost of \$13,637 after the bridge and previously installed wood barriers were struck several times. The steel I-beam barriers have also been struck at least three times since 2015.

The Lower Towamensing Township supervisors plan to install yield signs at the bridge to help slow down traffic.

## **Relocating Wagner & Fowlersville Bridges on Hold**

Another covered bridge in Columbia County is looking for a new home. Wagner Bridge (PA-19-15) is currently located near the entrance to Foxtail homes. It was moved there in 1994. The original plan was to relocate Wagner Bridge to the parking lot at the Columbia-Montour Visitors Bureau but that plan has run into a snag with owners of the parking lot. A plan was developed to move it to the Bloomsburg Fairgrounds but that, too, seems to have fallen through as well as another plan for the Borough of Berwick to find a home for the bridge. For now, the 1856 built, 62-foot bridge will remain at the entrance to Foxtail homes.

We reported earlier that the Fowlersville Bridge (PA-19-05) may be moved from Briar Creek Lake Park in Briar Creek Township to North Centre Township Park but

sources tell us that move will not happen. Dismantling and rebuilding the bridge is too costly and the cost to move the bridge without dismantling it is unaffordable at nearly \$100,000 as well as approximately 70 wires that would have to be lifted. Fowlersville Bridge will likely remain in Briar Creek Lake Park.


## Ramp's Bridge Gets Major Rehabilitation

Ramp's Bridge (PA-21-11) is the only remaining covered bridge in Cumberland County. Ramp's Bridge is currently undergoing a much needed rehabilitation. Work may be already be completed. Lumber was shipped from Oregon to replace one the Burr arches. The bridge was jacked up and supported with cribbing while the arch was replaced. It appears the project includes most of the bridge getting a new floor, new roof, new siding, replacement of any decayed or twisted timbers and fresh paint. Jay Fulkroad and Sons, Inc. of McAlisterville, PA was awarded the contract for the project.

## Martin's Mill Bridge Vandalized

Martin's Mill Bridge (PA-28-01) in Franklin County was spray painted with graffiti on March 8, 2021. Vandals painted words, symbols and images on the walls and floor inside the bridge as well as the roadway outside the bridge and the gate used to block out traffic. Parks Director Cheryl Walburn quickly painted over the graffiti. Pennsylvania State Police are investigating the incident.

Martin's Mill Bridge was nearly removed in 1962 but the community was successful in lobbying to save the bridge. It was swept downstream during Tropical Storm Agnes in 1972 but was rebuilt. It is one of only two remaining covered bridges in Franklin County.

#### Kintersburg Bridge Needs Repair

Indiana County has four covered bridges. All but one are in excellent condition. Kintersburg Bridge (PA-32-05) is in need of repairs and hopefully that may happen soon. Member Joe McCarthy of Lancaster Timber Frames visited the bridge to discuss its condition with Ed Patterson, also a Society member and Director of Indiana County Parks and Trails. At our May Society's meeting Joe informed us the bridge is in dire need of repair. Main trusses of the bridge are completely broken. He submitted a proposal to completely dismantle the bridge and rebuild it. 
#### North Oriental Bridge Struck by Truck

On May 18, 2021 an oversized truck broke most of the roof braces in the bridge. North Oriental Bridge (PA-34-05 & PA-55-05) crosses the West Branch of Mahantango Creek and connects Snyder and Juniata counties. PennDOT closed the bridge until repairs can be made. North Oriental Bridge carries over 800 vehicles per day. Fortunately, the driver of the truck that damaged the bridge did stop and report the damage to officials.

#### Banks Bridge to Get Complete Makeover

On March 16, 2021 Lawrence County Commissioners approved a contract with Allison Park Contractors, Inc. of Gastonia to make repairs to Banks Bridge (PA-37-02). Steel and wood repairs will be made as well as a fresh coat of paint at a cost of \$440,000. The bridge was closed to traffic on May 10<sup>th</sup> and will remain closed until about July 20<sup>th</sup> when work is scheduled for completion. Banks Bridge and McConnell's Mill Bridge (PA-37-01) are the only two still standing in Lawrence County.

## Keefer Station and Rishel Bridges in Northumberland Counties Vandalized

Northumberland County covered bridges often have a problem with vandals. Rishel Bridge (PA-49-05 #2) is often vandalized with graffiti as well as Keefer Station Bridge (PA-49-02). Siding has also been kicked out of Keefer Station Bridge. Litter, beer cans, and drug paraphernalia have been found at the bridge. Northumberland County Commissioner Joe Klebon asked for volunteers to help remove the graffiti. Klebon is also seeking funds to install surveillance cameras and plans to prosecute anyone vandalizing the bridges. Northumberland County has three covered bridges solely in the county, one they share with Montour County and three shared with Columbia County.

On Saturday, May 15<sup>th</sup>, the Line Mountain High School Football Team arrived at the bridge ready to paint over the graffiti at Keefer Station Bridge. Two hours later Keefer Station Bridge had a fresh coat of paint and no graffiti.

## Shaffer Bridge Gets Roof Repaired

Shaffer's Bridge (PA-56-11) in Somerset County has had its share of problems the last couple of years. Rotted heavy timber has plagued the bridge for a few years. A temporary fix was put in place last year to support the roof so small traffic vehicles could pass through.

The roof is filled with holes. Crews were at the bridge the week of March 15<sup>th</sup> to install a new metal roof. Although fixing the roof will help protect the bridge from the weather elements it does not address the major problem of stabilizing the bridge. On June 1<sup>st</sup> County officials obtained a \$100,000 Department of Community and Economic Development grant to replace the failing beams that support the bridge's roof. Hopefully, work will be able to start this coming winter unless conditions push the project to next spring.

## Hassenplug Set for Rehabilitation

Pennsylvania's oldest standing covered bridge will get some much needed rehabilitation this summer. Union County Commissioners approved funding for improvements to Hassenplug Bridge (PA-60-03). Member Joe McCarthy reported to our Society that work is scheduled to start this June or July. Hassenplug Bridge was constructed in 1825 and rehabilitated in 1959.

#### Bartram's Bridge

We have recently been informed by member Joe McCarthy that Bartram's Bridge in Chester/Delaware counties (PA-15-17 & PA-23-02) will be rehabilitated this coming fall, 2021. We should have more information about the plan in time for the October newsletter.

## CONNECTICUT Barn Yard Bridge

news about a new covered bridge in Connecticut. Barn Yard Bridge (CT-07-09) is located in Ellington Township, Tolland County. Barn Yard Bridge is a 56-foot, Town truss bridge built by Great Country Timber Frames. The skeleton of the bridge was put in place on April 7, 2021.

Barn Yard Bridge has a metal roof and Douglas fir was used for the flooring. The bridge is located on the Great Country Timber Frames property and the owners welcome visitors.

## DELAWARE Smith's Bridge Damaged by Tractor Trailer

On April 19, 2021 a tractor trailer attempted to cross Smith's Bridge (DE-02-01 #2) in New Castle County, Delaware. Seems the tractor trailer received more damage than the bridge. The portal boards on the east end of the bridge were damaged but there was no structural damage and the bridge remained open. The driver of the truck was charged with inattentive driving along with several commercial truck violations.

Smith's Bridge was originally built in 1839 but lost to a fire on Halloween night in 1961. In 2002 a new covered bridge was built at this location over Brandywine Creek.

## INDIANA Trailer Stolen From Spencerville Bridge

A trailer containing nearly \$25,000 worth of tools needed to finish the restoration of Spencerville Bridge (IN-17-01) along with a new historical marker for the bridge was stolen the morning of May 28, 2021. The trailer was found a week later but nearly all of the tools and the historical marker were gone.

Much of the lumber underneath Spencerville Bridge was found to be rotted away while work was being done this past winter. Crews worked through the winter to replace the lumber so they could finish the restoration before a reopening ceremony planned for late June. Completion of the bridge restoration has been delayed. Spencerville Bridge is monitored by a surveillance camera.

Phase One of the restoration project was to stabilize the bridge with steel supports to keep it from falling into Coal Creek. Work for Phase One was completed in December of 2019. Phase Two of the project is to replace the rotted lower chords and the flooring. Work is scheduled for this summer or fall at a cost of \$292,475. Phase Three is to repair the siding and Phase Four is to paint the bridge and provide signage. Once the project to restore Cades Mill Bridge is complete plans will be put in place to restore Wallace Bridge (IN-23-01).

## KENTUCKY Beech Fork Bridge Destroyed by Fire

We have lost another covered bridge, likely by arson. Beech Fork/Mt. Zion Bridge (KY-115-01) burned down on March 9, 2021. Sheriff Jerry Pinkston, of Washington County, was alerted to the fire about 11 p.m. As of Wednesday morning, March 10<sup>th</sup> the bridge was completely destroyed. Beech Fork Bridge had been restored in 2017 by Arnold Graton & Associates of New Hampshire. When the bridge was restored a fire retardant was applied. The fire retardant was not enough to save the bridge from the intensity of the fire. Surveillance video appears to show the bridge was basically "blown up."

## NEW HAMPSHIRE Bement Bridge Back in Place, Whittier Bridge Stays Put

Contractors are simply too busy to place bids to relocate Whittier Bridge (NH-02-08) over Bearcamp River in Carroll County. Whittier Bridge has been closed since 2008. There are only two area contractors qualified to move the bridge and both are simply too busy with other projects. Two efforts to obtain bids to move the bridge have failed. Officials will make another attempt this year to receive a bid to move the bridge and hopefully it will be moved early next year.

Bement Bridge (NH-07-03) in Merrimack County was moved about 50 feet upstream last year so crews could replace the abutments. New granite abutments were built on existing bedrock. Daniels Construction performed the work on the abutments as well as replacing a number of deteriorated timbers. Bement Bridge was moved back over the West Branch of Warner River on April 27<sup>th</sup> using rollers on a steel frame pulled by winches and cables. Crews will now reinstall the siding. The total cost of the project is approximately \$1.65 million.

## OHIO Good News for Knowlton Bridge

Knowlton Bridge (OH-56-18) in Monroe County has lost two of its three spans over the last few years. As plans were being made to replace the first span that collapsed, the second span gave way. Monroe County officials are determined to have the bridge rebuilt and likely reopened to traffic. Officials visited a large area of

county-owned property in an effort to locate timber that would be usable to rebuild the bridge. They located at least 115 white oak trees that could be used for the project. Use of the local lumber could significantly reduce the cost of the project estimated to be about \$1.3 million. The Ohio Department of Transportation has provided a \$950,000 grant for the project.

ODOT originally required Monroe County to provide \$45,000 in matching funds, but has now considered the use of the local timber an equivalent to matching funds.

ODOT will now provide 100% of the funding for the project providing local lumber is used. The design work for Knowlton Bridge is complete so the next step is to

put the bridge rebuild project out for bids. County officials are hopeful work can be started later this year or early 2022.

Knowlton Bridge is owned by the county and located in Covered Bridge Park where there is a picnic area. It was placed on the National Register of Historic Places on March 11, 1980.

#### Mary Ruffner Bridge to be Relocated

Owners of the Mary Ruffner Bridge (OH-64-84) in Perry County are willing to have the bridge removed from their property and relocated to another area where it can be enjoyed by more people. The bridge was moved to their property from Fairfield County in 1986. It appears now it may be going back to Fairfield County. Sensory Trail Park was acquired by lease from the Board of County Commissioners of Fairfield County in 2017. The little park would like to have the Mary Ruffner Bridge relocated there. The cost to dismantle, relocate and rebuild the bridge was originally estimated to be \$400,000. An effort to cut those costs has been successful thanks to help from Michael Tharp, Superintendent of Lancaster Parks and Recreation. Quotes obtained by Tharp include \$40,000 to move the bridge and \$150,000 for removal of the roof and awnings for transport, permit



## ONTARIO, CANADA West Montrose Bridge Set For Rehabilitation

West Montrose Bridge (59-50-01) is the only remaining covered bridge in Ontario, Canada. The 1881 built, Queenpost truss bridge is also known as Kissing Bridge. Canadian and Ontario governments and the Waterloo Region announced \$6.25 million in joint funding to rehabilitate the bridge. According to an article in *Construction Canada*, "Work will include removing and replacing steel bailey trusses with concealed steel girders, repairing and replacing the roof, and reinstalling the fire alarm system. While under construction, the bridge will be temporarily supported to preserve its structural integrity and heritage design."



## ← Looking Back ← Schofield Ford Bridge

Schofield Ford Bridge (PA-09-13 #2) crosses Neshaminy Creek connecting Newton and Northampton townships in Bucks County. It is also known as Twining Ford Bridge. It is located on a trail system for horse and pedestrian traffic in Tyler State Park. The first bridge at this location was likely built in the mid-1800s and lost to arson on October 7, 1991. The hemlock planks and cedar-shake roof were consumed by fire that destroyed the bridge in less than a half hour.



Greenwood headed a fundraising committee to rebuild Schofield Ford Bridge. Money was raised through the sale of color prints, jars were placed in restaurants and stores for donations and various horse shows and bike and hike events were held. By the fall of 1995 the abutments & piers were completed. Construction of the bridge began in the summer

of 1996 by Woodhouse Post & Beam Company of Mansfield, PA. The cost of the project was \$350,000. The new bridge was an exact replica of the first bridge including the series of Queenpost trusses that ran the entire length of the 166 foot, 2-span, Town Lattice truss structure. Schofield Ford Bridge was dedicated on

September 6, 1997. It is the longest covered bridge standing in Bucks County.


